# Product

### **Product description:**

Ørsta-bolt is anchored with polyester cartridge and is used for both work support and permanent rock securing. The bolt is delivered with mixing spring, and can be used for rock

securing all the way to the working face.

#### Product specification

We have our own production in Norway and use high quality Norwegian-produced recycled reinforcing steel.

The steel is hot-dip galvanized. In corrosive environments the bolt can be delivered with a layer of powder coating (CombiCoat®) to achieve 120 years of corrosion protection.

(ref.: SINTEF research report based on laboratory testing in collaboration with Vik Ørsta AS)

All of our rock support bolts is produced according to NS-EN 1090, delivered CE-approved and follows the requirements of Norwegian Public Road Administration (Statens Vegvesen) handbook 761.

The bolt is delivered with mounted mixing spring and nut. Hemispherical dome and plate must be ordered separately but are included in the EPD

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. ### Allocation:


The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation.
