Circular VAV terminal units for variable and constant air volume systems, suitable for supply or extract air, available in 7 nominal sizes. High control accuracy even in case of unfavourable upstream conditions. Control range at least 1:25. The effective pressure is captured by means of the damper blade, which is controlled accordingly. The effective pressure is transmitted to the control component via a channel in the shaft (no measuring tubes required). Closed blade air leakage to EN 1751: at least class 3, from NS 200: class 4. Casing air leakage to EN 1751, class C. Ready-to-commission unit which consists of the mechanical parts and the factory mounted electronic control component. #### Allocation:

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. 
