Circular shut-off dampers for shutting off or restricting the airflow in ventilation ducts of air conditioning systems, for supply air or extract air, available in 7 nominal sizes. Suitable for duct pressures up to 1500 Pa. Ready-to-install unit which consists of a casing with a damper blade. Spigot with groove for lip seal, suitable for connecting ducts according to EN 1506 or EN 13180. Position of the damper blade indicated externally at the shaft extension. Closed blade air leakage to EN 1751, class 4 (nominal sizes 100, 125 and 160, class 3). Casing air leakage according to EN 1751, class C.

## **Cut-off criteria:**

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

#### Allocation:

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.



# Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


