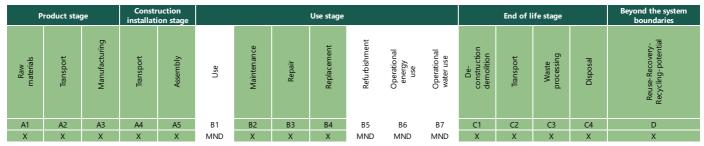
# Data quality:

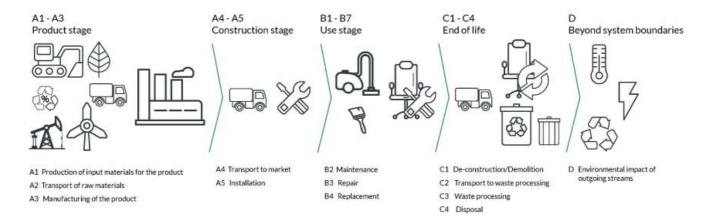
