



Each OPTIMA type has a specific equation. The correction factor is calculated by multiplying a coefficient by the area "A" in m<sup>2</sup>, derived from the product's nominal dimensions and adding a constant.

The equation for each type is as follows:

OPTIMA-S-FC factor = 5,677508 \* A + 0,60125997

OPTIMA-S-FM factor = 0,895499 \* A + 0,7417879

The coefficients and constants in each equation are specific to each product type and adjust for GWPtot differences between models. These equations enable you to estimate GWPtot correction factor for product sizes not listed in the table. By calculating "A" for desired product size and applying the appropriate type of equation, you can determine the GWPtot correction factor.


#### **Allocation:**

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.




#### Remarks to environmental impacts




