Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.


Data quality:



Concrete exposed for long-term water contact (XC2), concrete inside buildings with moderate or high air humidity or external concrete sheltered from rain (XC3), concrete surfaces subject to water contact not included in XC3 e.g. external walls, facades, balconies etc. (XC4), vertical concrete surfaces exposed to rain and freezing (XF1), and concrete exposed to natural soil and ground water with slightly aggressive chemical environment (XA1).
